**SOUTHERN TERRITORY**  
**By-LAWS**

(Revised 10-22-2017, Greensboro, NC)

**ARTICLE 1: TERRITORY MEMBERS**

- 1.01 The fifteen regions listed in **Article 202** of the ASA Code shall be organized into four territories as follows:
  - A. Eastern (inclusive of Regions: 1 and 2)
  - B. Southern (inclusive of Regions: 3, 4 and 5)
  - C. Northern (inclusive of Regions: 6, 7 and 8)
  - D. Western (inclusive of Regions: 9 and 10)
- 1.02 The Southern Territory association members are:
  - A. Southeast Region 3: Florida, Georgia, South Carolina and Tennessee.
  - B. South Region 4: Alabama, Arkansas, Louisiana and Mississippi.
  - C. Southwest Region 5: New Mexico, Oklahoma, Texas, Metro Dallas/Fort Worth, Metro Houston and Metro San Antonio.

**ARTICLE 2: VOTING**

- 2.01 On all matters coming before the Territory, each Territorial Council member shall be entitled to one vote.
- 2.02 A quorum shall consist of at least fifty percent (50%) plus one of the Territory Council members.

**ARTICLE 3: REGIONAL VICE PRESIDENTS**

- 3.01 A. The Southern Territory consists of Regions 3, 4 and 5. Each Region will elect a Regional Vice President to serve for a term of two years. Regional Vice President’s elections will take place per rotation established by the USA Softball Code.
- B. The Regional Vice Presidents will appoint a Southern Territory Secretary for a one (1) year term beginning in November 2016.
  - 1. The Southern Territorial Secretary responsibilities shall include keeping the meeting minutes of the Southern Territory and other responsibilities as prescribed by the Regional Vice Presidents.

**ARTICLE 4: TERRITORIAL EXECUTIVE BOARD**

- 4.01 A. The Territorial Executive Board shall consist of the Region 3, 4 and 5 Regional Vice Presidents, the Regional Directors and any Territory member that is on the ASA National Board of Directors.
- B. The Executive Board shall conduct the business of the Territory including but not limited to the following:
  - 1. Arrange the meeting place and agenda for all Territory meetings.
  - 2. Maintain information on tournaments and awarding of tournaments.
  - 3. Maintain the minutes of all meetings.
  - 4. Conduct all elections for Territorial offices.

**ARTICLE 5: ADMENDMENTS**

- 5.01 The By-Laws may be amended under the authority of Robert’s Rules of Order by a motion, second and majority of the voting delegates within the Territory only at a posted meeting of the Territory at the annual National Council meeting.

**ARTICLE 6: SOUTHERN TERRITORY TOURNAMENTS**

- 6.01 A. All Southern Territory Tournaments will be awarded on a rotation basis.
  - B. The host sites for each rotation tournament will be awarded by the Region in which the tournament site is located.
  - C. Each Region will determine the manner in which a tournament site is selected.
  - D. The Territorial Vice Presidents should provide the host site information to the ASA National office staff as soon as the sites are selected.
